The Hon Secretary was given the go ahead for appointment of Project Safety Supervisor as well as for the appointment of Asbestos surveyor.

The Council gave the go ahead for decisions of the Loss Adjuster re quotes on Kitchen stripping, and rebuilding in consultation with the Hon. Secretary.

A decision was made to reopen the bar as soon as cleaning was completed and alarm was in full working order. Initially al we provide would be drink as well as tea and scones. Clair Doherty would continue to employed for this purpose.

It was agreed that an email be sent to members to inform them of the accidental nature of the fire and to give and them an update on the progress to date and expected timeframe for various works.

The council decided that there was no cause to repudiate the contract with Peter McEvoy and would do work to have him back in operation as soon as possible.

As Peter McEvoy would continue as franchisee he would advise on the kitchen refit in consultation with Oliver Meuller and others who had expertise in this area. The loss adjuster would also have an input and the final decisions would be made by the Council.
